Contestants must be: (a) Male (b) a resident of Ohio (c) at least 21 years of age and (d) must possess a valid Ohio drivers license.

Contestants must attach to this application a good quality 3” or 4” color photograph (of themselves only) for use on the Mr. Ohio Leather Web Site and contest program booklet.

There is a registration fee of \$25 for entry to the contest.

Should You Win the title of Mr. Ohio Leather, 2009...

1. The title-holder only continues onto the next level if he wishes to do so (to whichever contest HE deems appropriate). If he opts to not go, then the Ohio Leather Brotherhood recipient can fill the slot. If they both opt not to go then it can be offered to the 1st and 2nd Runner up. If nobody wishes to go then the title will not be represented.
2. The Mr. Ohio Leather board will not dictate to you where you need to go or what you should do during your year. That is up to you. Please note that you might be asked to help raise the funds to compete at the next level.
3. It is understood that spouses, partners and many others are essential for the success of our Titleholder, Brotherhood and Runner-up winner(s). However, it must be understood that at no time will any third party be permitted to negotiate, speak for or make decisions for the titleholder. We do encourage well-wishers, however, to all those considered a third party- respect both the title holder's position and the board of trustees and their decisions.
4. Communication between the title-holder and the subsequent winners (brotherhood, 1st & 2nd Runner Up) is essential. All title-holders will communicate at least once a month with the rep of the contest or the board in the form of at LEAST an email. If there is an event that is planned between emails or conversations, the title-holder must notify the contact person or the board so arrangements can be made for advertising your event in the correct venues.
5. Mr. Ohio Leather will assist in paying for hotel and expense of traveling (within reason and approved by the board prior to booking or purchase.) for the person who continues on to the next contest (not including incidentals, food, beverage, gratuities) to and from their next level of competition in the form of the prize money and the creation of a travel fund. Any other ways of making money to help sustain the traveling of Mr. Ohio Leather are always welcome.
6. While wearing the Mr. Ohio Leather colors on their person the title-holder or board member may not be intoxicated or impaired by illegal substances. If this occurs, disciplinary action can and will be taken.
7. Any employee, representative or partners of Rhoades Inc. or Mr. Ohio Leather are excluded from competing as it would be deemed as a conflict of interest.
8. If there is one contestant then that person must make 80% of the total score. If that person does not make the score then the title is not represented for the year. It is then at the producers discretion and current titleholder to decide the next step.
